In accordance with the policy revision of the "Support for Pioneering Research Initiated by the Next-Generation (JST-SPRING)" conducted by the Japan Science and Technology Agency (JST), the selection in April 2026 has been significantly revised from previous application cycles. The main changes are as follows. Applicants and their (prospective) primary supervisors must read the Application Guidelines carefully before applying.

- SPRING Japanese Students:
- Changes to application requirements (new limits on the number of months enrolled at the time of application and on the number of times one may apply)
- SPRING International Students:
 - -Changes to application requirements (addition of MEXT scholarship students; restriction of application timing solely to the month of enrollment in a Doctoral Level Section of Integrated Course / Doctoral Course (for the April 2026 recruitment period, this applies only to privately financed international students); application requirement regarding contributions to science, technology, and innovation in Japan)
- -Changes to financial support (not eligible for the grant for living expenses or half tuition exemptions; RA salaries granted only to selected applicants recognized as truly outstanding)
- Preliminary Selection:

Changes to application requirements (addition of 4-year Doctoral Course as eligible advancement destinations for preliminary awardees; expanded eligibility for those who advance to or are enrolled in the 5th year, as well as those who advance to the 6th year of the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences)

The present call for HaKaSe⁺ for SPRING and HaKaSe⁺ Preliminary Selection is based on the assumption that the government will continue its doctoral student support programs beyond FY 2026. Please note in advance that, depending on future governmental system revisions or budgetary conditions, changes may occur—such as revisions to eligibility based on nationality or residence status, reductions in support levels, or modifications to the content.

Furthermore, all references in the Application Guidelines to "Japanese students" denote those who are marked with a O in the categorization titled "Students Eligible for Grant for living expenses under the New System" indicated in connection with the SPRING policy revision (see the URL below).

Important Notes on Application

Doctoral talents are expected to contribute "Science, technology, and innovation in Japan."

Kanazawa University also focuses on fostering and producing doctoral talents with one of the significant missions for Kanazawa University to strengthen the functions of the graduate school, and thereby enhance its research capabilities.

The following projects implemented under the "Kanazawa University Strategic Project for Development of Doctoral Students and Research Promotion (HaKaSe⁺)" are all carried out by Kanazawa University supported by the Japan Science and Technology Agency (JST).

[HaKaSe⁺ projects]

- SPRING Project for Doctoral Talents in Creating Novel Values (HaKaSe⁺ for SPRING)
- BOOST Project for Trailblazing AI Crossover Doctoral Talents (HaKaSe+ for BOOST)
- Preliminary Selection of Kanazawa University Strategic Project for Development of Doctoral Students and Research Promotion (Preliminary Selection of HaKaSe⁺)

These projects provide an environment where excellent students of the Doctoral Level Section of Integrated Course / Doctoral Course (hereinafter referred to as "doctoral students") being responsible for the future of science, technology, and innovation in Japan to concentrate on their research without financial worries, as well as various supports for career development as doctoral talents.

Therefore, applicants are to understand the following matters and carefully read and confirm this Application Guidelines before applying.

- 1. An awardee will be required to present research achievements in academic conferences and academic journals, complete doctoral course of Kanazawa University within standard period of course, and obtain a doctoral degree as a student supported by Japanese government funding to develop doctoral talents who will contribute to "Science, technology and innovation in Japan."
- 2. In order to increase independence and activeness in going on to doctoral course, and to increase responsibility for conducting research in doctoral course, HaKaSe⁺ have limited the application of admission fee waivers and tuition waivers for students selected for HaKaSe⁺ for SPRING and HaKaSe⁺ for BOOST from April 2024 onwards.
- 3. HaKaSe⁺ will take action such as suspending the support, cancelling the award or demanding the refund of all of the financial supports in the case that HaKaSe⁺ finds and confirms the fact that an awardee is in conflict with the Qualifications for application or Obligations of awardees.
- 4. Career of each awardee will be tracked for more than 10 years after completing the Doctoral Level Section of Integrated Course / Doctoral Course as a selected student supported by Japanese government funding.

1. Purpose and Outline of HaKaSe⁺

Kanazawa University is focusing on fostering and producing doctoral talents who will be the seed of innovation both in Japan and around the world, and be responsible for creating a future society.

The **HaKaSe**⁺ has the following individual projects as major pillars of HaKaSe⁺, supported by the Japan Science and Technology Agency (JST), and reinforces support for doctoral students as well as encourages our students to advance to the Doctoral Level Section of Integrated Course / Doctoral Course.

- SPRING Project for Doctoral Talents in Creating Novel Values (HaKaSe+ for SPRING) [From FY2024]
- BOOST Project for Trailblazing AI Crossover Doctoral Talents (HaKaSe+ for BOOST) [From FY2024]

Each of these individual projects aims to nurture talented doctoral talents who can contribute to society, by reinforcing support such as financial support, enhancement of the environment for concentration on research, development of interdisciplinarity and internationality, career development after obtaining a doctoral degree, etc.

Doctoral students who apply to and are selected for HaKaSe⁺ will be supported by one of the projects based on the specific support provided by that project. This support may include grants for living expenses, research funds, travel subsidies, or other financial assistance. The goal is to create an environment conducive to dedicated research while requiring recipients to fulfill the obligations imposed by HaKaSe⁺ and the relevant project.

In addition, students who advance to or are enrolled in the Master's Level Section of the Integrated Course / Master's Course as well as those who advance to or are enrolled in the 5th year of the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences and those who advance to its 6th year, will be selected as "Preliminary Awardees" for HaKaSe⁺ on the condition that they pledge to further advance to the Doctoral Level Section of the Integrated Course / Doctoral Course at Kanazawa University. Preliminary Awardees are supported to reduce their financial burden during the enrollment in the Master's Level Section of Integrated Course / Master's Course or during the enrollment in the 5th and 6th years in the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences.

HaKaSe⁺ recruits ambitious students who are willing to pursue challenging and interdisciplinary research that aims to create new knowledge based on their high level of expertise and research capability and to lead to create novel values in society.

The details of each project are as follows.

[SPRING Project for Doctoral Talents in Creating Novel Values (HaKaSe+ for SPRING)]

This project is designed to foster innovative doctoral talents in KU co-educational environment through co-creation and exchanges of knowledge, who can develop their advanced expertise in diverse sectors and fields of society, and create novel values for the future. HaKaSe⁺ for SPRING supports excellent and aspiring doctoral students with a wide view that is transcends their own research field, as well as attitude and capability to take on challenges to face social issues. These doctoral talents are expected to contribute to the progress of science and technology, and the creation of innovations both in Japan and around the world.

[BOOST Project for Trailblazing AI Crossover Doctoral Talents (HaKaSe⁺ for BOOST)]

This project is designed to foster doctoral talents who promote cutting-edge AI theoretical research and AI applied research in various research fields, backed by advanced AI knowledge and skills, and lead next-generation AI research and development. HaKaSe⁺ for BOOST places emphasis on having the qualifications to take on challenges in the AI academic field with an inquisitive spirit and conduct creative AI research. Therefore, this project supports not only doctoral students who are promoting theoretical or applied AI research and already have knowledge, skills, and research experience related to AI research, but also those with a strong desire to incorporate AI in their own research field and promote research.

The students selected for HaKaSe⁺ for BOOST are to catch up on rapidly evolving AI technology, acquire skills as AI engineers or data scientists, and utilize these skills to reach the level where they can carry out AI research and development that is most optimal for their own research. Besides, selected students are required to present AI research in academic conferences and academic journals.

Therefore, selected students of HaKaSe⁺ for BOOST will be required to participate in "Al theoretical education", "Al lectures and practical training", "Al catch-up seminars", and "Al research exchanges" conducted by this project. Furthermore, in order to promote knowledge circulation and accelerate Al research at Kanazawa University, HaKaSe⁺ for BOOST requests selected students and their supervisors to share the sample data, sample code, and know-how across Kanazawa University from their Al research when achieving research results in academic journals, in the case that this does not interfere with patent applications, preservation of security/privacy/confidentiality.

[Preliminary Selection of Kanazawa University Strategic Project for Development of Doctoral Students and Research Promotion (Preliminary Selection of HaKaSe⁺)]

Note: Applications will only be open to Japanese students in accordance with the policy revision of the JST-SPRING.

This is a system that HaKaSe⁺ selects the following students as preliminary awardees, who pledge to go on to the Doctoral Level Section of Integrated Course / Doctoral Course of Kanazawa University and to play an active role after obtaining a doctoral degree. Preliminary Awardees are exempted from admission and tuition fees (as specified in 2. Outline of the Support 2) Contents of financial support), and allowed to participate in various programs within the research environment.

- Those who advance to or are currently enrolled in the Master's Level Section of the Integrated Course / Master's Course
- Those who advance to or are currently enrolled in the 5th year of the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences
- Those who advance to the 6th year of the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences

In order to be supported by HaKaSe⁺ in the Doctoral Level Section of Integrated Course / Doctoral Course, preliminary awardees are required to pass the selection screening of HaKaSe⁺ after they pass the entrance examination for the Doctoral Level Section of Integrated Course / Doctoral Course of the graduate school of Kanazawa University. As a result of the selection screening, those who pass will be selected students of "HaKaSe⁺ for SPRING", and supported under the project. However, HaKaSe⁺ for SPRING from FY2026 onwards is based on the assumption that the support project to doctoral students by Japanese government will continue. Therefore, this is subject to change.

At Kanazawa University, in principle, students who advance to the Doctoral Level Section of Integrated Course / Doctoral Course are to complete the Master's Level Section of Integrated Course with Qualifying Examination (QE). Therefore, obviously, this principle will apply to the Preliminary Awardees who are enrolled in the Master's Level Section of Integrated Course, making a commitment to advance to the Doctoral Level Section of Integrated Course (/ Doctoral Course).

<u>Financial support is a special case for awardees and preliminary awardees of HaKaSe</u>⁺. Therefore, in the <u>case where an awardee in HaKaSe</u>⁺ declines the award or preliminary selection, or in other case, support <u>may be stopped.</u> Besides, in this case, refund of the grant for living expenses, research funds and all <u>other financial support provided by HaKaSe</u>⁺, payment of the exempted admission fee and the exempted <u>tuition fee may be requested.</u>

<u>Please note that the contents of financial support may change depending on the situation of budget and system changes, etc.</u>

For international students selected, if he/she cannot arrive in Japan by the date of adoption after the selection decision, the grant for living expenses for the month(s) that has/have the non-arrival day(s) will not be paid. In the case that international students arrive in Japan in the middle of a month, the payment of the grant for living expenses will start from the following month. Research funds can also be used from the month in which the payment of the grant for living expenses begins.

If an awardee of one of the projects in HaKaSe⁺ that offers a half-tuition fee exemption applies for our university's own tuition fee exemption, and the result of application is a half-tuition fee exemption, only the half-tuition fee exemption through HaKaSe⁺ will be available.

3. Application Requirements

1) Number of students to be selected

The number of students to be selected is described in the following table.

Applicants have to confirm their qualifications for application stipulated in 2) and choose the preferred project at the time of application. The project in which an applicant will be selected is decided by HaKaSe⁺ based on the selection result and the content of their research plan. Therefore, applicants should be aware that the applicant's wishes may not be met.

2) Qualifications for application

We welcome applicants who understand the purpose of HaKaSe⁺, have a high motivation for research toward obtaining a doctoral degree within standard period, have an inquisitive spirit, and after obtaining a doctoral degree, wish to develop a profound academic expertise in various sectors of society, thus contribute to the advancement of Japanese science and technology, the creation of innovation, the realization of a better future society with. All of the following requirements must be met.

It should be noted that since the concept of Preliminary Selection of HaKaSe⁺ is to support those who pledge to play an active role after obtaining a doctoral degree, those who advance to or are enrolled in the Master's Level Section of Integrated Course / Master's Course, as well as those who advance to or are enrolled in the 5th year of the School of Pharmacy in the College of Medical, Pharmaceutical and Health Sciences or who advance to its 6th year, but do not pledge to advance to the Doctoral Level Section of Integrated Course / Doctoral Course are not qualified.

Document Screening

Document Screening will be reviewed based on the submitted application documents.

It should be noted that in Document Screening, for those enrolling on April 1, 2026, the results of the graduate school enrollment entrance examination for the Doctoral Level Section of Integrated Course / Doctoral Course or the Master's Level Section of Integrated Course / Master's Course' conducted by the relevant division of the graduate school will be referred to. For those advancing to the 5th or 6th year of the 6-year Bachelor's Program, information regarding the advancement assessment conducted by the relevant school will be referred to.

Interview

6. Announcement of the Selection Result and Date of Adoption

The result of the selection will be notified to the applicants via the e-mail at the addresses stated in the application documents by the end of March, 2026.

Date of Adoption of HaKaSe⁺ will be April 1, 2026.

7. Obligations of Awardees

Awardees are obliged to fulfil the following items. If HaKaSe⁺ finds that they have failed to fulfil obligations of awardees, or if HaKaSe⁺ finds that it is not appropriate to continue the support based on the report referred to in 4), HaKaSe⁺ will take action such as suspending the support, cancelling the award or demanding the refund of the financial support.

The selection of the program to participate and the number of times of participation must meet the requirements indicated separately by HaKaSe⁺.
- 3) For awardees of HaKaSe⁺ for BOOST, 2) is recommendation.
